Ogopogo Triathlon Club Membership Agreement

- 1. As the Member is under 18 years of age (a "Minor"), the person identified in ZONE 4 registration as the "Parent/Guardian" represents and confirms that the Parent/Guardian is 18 years of age or over; has the legal capacity and authority to make this agreement on behalf of the Minor; binds and is effective against the Minor.
- 2. The Member will comply with all other Club policies which from time to time apply to the Member.
- 3. - 4. The Member will comply with Club Volunteer commitments agreed upon and upon request will help with additional duties to the best of the Members ability in order to ensure vital club operation.
- 5. The Member will pay to the Club, when due, the full amounts of the fees and other charges due by the member.
- 6. The Member is aware of the Club's personal information protection policy, and consents to the use of the member's personal information in the manner specified by the policy. The Member consents to the distribution to Ogopogo Triathlon Club of the Member's name and contact information provided to the Club, for mailing or emailing list and Club contact list purposes.
- 7. The Member consents to the Club's publication of photographs or videos containing images of the Member.
- 8. The Club reserves the right to alter or cancel programs which do not attain sufficient enrollment.
- 9. Participation in any Club program and dryland activities is conditional upon the Member registering and granting a release and liability waiver (electronically or hardcopies) in favour of the Club, its volunteers, coaches and others, in the form prescribed by the Club from time to time.
- 10. The Member contractual relationship with the Club is governed by the laws of the Province of British Columbia and the applicable federal laws of the Dominion of Canada. This is the entire agreement between the Club and the Member respecting the Member's membership in the Club, and there are no representations, warranties or collateral agreements not set out or incorporated by reference in this Membership Agreement.
